

## **Vision for Botley**

In 2036, Botley remains a warm and friendly place to live, work and to visit. New developments have been well incorporated into the Parish through our sensitive Neighbourhood Plan policies and have provided homes needed by both the local and wider community and for all generations.

Well managed infrastructure and resource facilities provide residents with a quality environment, good access to health care, excellent educational opportunities and reliable access to modern technologies.

Local children and young people can walk or cycle safely to their educational establishments or the play and green areas on the many footpaths and cycleways introduced over the last 20 years. These routes provide a healthy alternative network for pedestrians and cyclists throughout the locality and link to neighbouring parishes.

The by-pass has been built and an update to the routing system traffic calming measures in the Parish has led to a decrease in rat-runs and have been effective in creating safer roads.

The village centre has been recognised as an important for its heritage, businesses and shops and provides a popular destination for locals and visitors alike

## Neighbourhood Plan Economy Objectives:

**Aim:** To support the existing businesses within Botley and encourage new enterprises which maintain the distinctive character of Botley by:

### Objectives:

1. Preserving and safeguarding, where appropriate, employment uses and seek to maintain a lively mix of retail and similar uses in the shopping area
2. Promoting the further retail development of Botley Mills site
3. Supporting the development of retail facilities in Boorley Park and Boorley Gardens earlier than identified in the Eastleigh Local Plan

## Neighbourhood Plan Environment and Character Objectives

**Aim:** To preserve, safeguard and enhance the distinctive landscape and characteristics of Botley by:

### Objectives:

- 4 Protecting and maintaining existing green space, archaeological and heritage assets deemed to be of value to the community including the provision of new spaces
- 5 Protecting and maintaining existing Settlement (Local) Gaps and the Countryside between settlements
- 6 Preserving native wildlife and wildflowers in local green spaces
- 7 Creating a Botley Museum through use of developer contribution
- 8 Improving access from Village Square to Botley Mills through use of developer contribution
- 9 Identifying a site for a new cemetery in the Parish

## Neighbourhood Plan Housing Objectives

**Aim:** To provide a range of high quality and affordable homes that meet the needs of local people and future residents by:

### Objectives:

- 10 Prioritising future development sites, to ensure appropriate infrastructure is in place prior to build
- 11 Ensuring all new development includes an appropriate mix of housing in terms of design, affordability to meet the objectively assessed housing need findings
- 12 Ensuring new development in Botley is of appropriate design and fits with the general character of Botley
- 13 Ensuring new developments and housing extensions, out-buildings, garages and conservatories, including those under Permitted Development Rights, are consistent with the requirements of the strategic high and intermediate pressure pipelines passing through the Parish
- 14 Supporting the use of alternative energy systems, for example solar panels
- 15 Ensuring all houses in new developments contain electric charging points in line with Government policy
- 16 Requiring new developments to provide minimum re-cycling facilities

## Neighbourhood Plan Transport Objectives

**Aim: To improve accessibility and connectivity to promote sustainability and safety by:**

- 17 Using developer contribution to improve parking at the Botley Centre
- 18 Identifying land within development sites for parking
- 19 Using developer contribution to improve the network of movement routes linking key services, schools and recreational pursuits, both from existing and new developments

## Community Aspirations

It is recognised that these aspirations do not form part of the policies of the Botley Neighbourhood Plan. However, they are of importance to the local community. For this reason, they are included as an Appendix to the Plan, in order that they can be taken forward after the Plan is adopted.

| 8                | Continue to work with Eastleigh Borough Council to ensure that development plans enable residents to have easy access to local retail, leisure and public transport facilities   |
| 9                | Provision of Community Information Terminals in both Parish Community Centres for use by the residents who have no access to the internet  |
| 10               | Further develop the Community Information Day and ensure the continued funding for the Community Liaison Officer, when the Section106 support for the post ceases  |
| 11               | Botley Parish Council to consider in all decisions and policies working towards a carbon neutral position and to work with other Agencies to help achieve this   |
| 12               | Botley Parish Council to encourage all residents with wood burning stoves to ensure that all wood used is well-seasoned (dry)  |
| 13               | Botley Parish Council will work with local Councils, other relevant Agencies and the community to support moves to reduce air pollution  |

| 14               | Create community led resources in Boorley Gardens to provide employment and training opportunities for younger people in the Parish  |
| 15               | Encouraging local businesses to actively support the reformation of a Botley Traders Association   |

| 19                | Ensure that as far as possible all pupils living within the Parish have access to thriving and sustainable schools within their local catchment school  |
| 20                | Maintain a community wide approach to primary education within the Parish with new schools working closely with existing provision to retain outstanding delivery and equal opportunities for all children  |
| 21                | Ensure that multi-agency support is in place to support the physical, emotional, social and education development of children and young people within the Parish so that they can reach their full potential  |
| 22                | Ensure that within a proposed planning submission for any new housing development there are funded proposals to make inclusive educational provision within an agreed time period to meet the aspirations of families, children and young people. Also, priority should be placed on ensuring all pupils and families living within Botley Parish have access to their local catchment school   |
| 23                | Ensure further consultation takes place with the Parish Council concerning road traffic flow, car parking and pedestrian access in respect of any proposed or planned additional school buildings or extension to educational facilities within the Parish  |
| 24                | Ensure that pupils who are resident within Botley Parish have safe access, whether on foot, by bicycle or by car, when travelling to and from School whether it be within or beyond the Parish boundary   |

| 25                | Improve the medical and NHS dental services, both around the Village centre and at Boorley Green  |
| 26                | Ensure that the residents of Botley continue to have access to the Appointments Plus (Hub) service at Botley Surgery  |
| 27                | Ensure that there is an Automatic External Defibrillator at the Boorley Park Community Centre, the Boorley Park Sports Pavilion and in an appropriate location in the Boorley Gardens development   |
| 28                | Monitor the views of the St Luke's & Botley Patient Participation Group and the results of the annual General Practice Patient Satisfaction Survey to confirm and improving service   |
| 29                | Be actively involved in public consultation carried out by the local Clinical Commissioning Groups regarding changes in the provision of the General Practice services in Botley  |
| 30                | Monitor any planned changes on the inner catchment area boundary of Hedge End Medical Centre and their possible impact on Botley residents  |
| 31                | Botley Parish Council to consider an annual contribution to the Hedge End Teenage Drop-in Centre  |
| 32                | Work with providers of community-based health screening and education to see what services could use Parish buildings or car parks  |
| 33                | The Parish Council will use the annual Community Information Day as a way of encouraging all the many groups providing activities and support that have health benefits to reach a wider audience in the community  |

| 34                | Encourage owners of older properties to upgrade wall and loft insulation to improve the energy efficiency of their houses   |

| 51                    | Improve the linkage to important transport hubs, retail facilities and healthcare providers outside the Parish   |
| 52                    | Ensure that measures are in place to encourage through traffic to use the Botley Bypass, as the new A334, including advice not to follow Sat Nav routes through Botley Village centre  |
| 53                    | Work with Winchester City Council and Hampshire Highways to determine if appropriate traffic control at the roundabouts at either end of the Botley Bypass is required to facilitate effective traffic flow  |
| 54                    | Continue to monitor measured air pollution, particularly in the region of children walking to school, and work with Eastleigh Borough Council and Hampshire Highways if mitigating measures are required   |
| 55                    | Ensure robust traffic management plans are in place for all housing and major highway developments   |
| 56                    | Improve the Square: <ul style="list-style-type: none"> <li>○ with additional car parking in the Square</li> <li>○ by considering making the Square a shared space for pedestrians and traffic</li> <li>○ ensuring available and well-placed delivery sites</li> <li>○ by instituting a 7.5 tonne weight restriction except for deliveries</li> <li>○ by reducing speed through the Square by use of suitable traffic calming measures</li> </ul> |

| 60           | Work with landowners and the developers of the new Boorley Park Primary Scholl to create a safer parking and child drop-off area at the School  |
| 61           | Work with Hampshire Highways to use traffic survey data from before and after the opening of the Bypass to identify any rat-runs and formulate appropriate traffic measures to reduce the use of these  |
| 62           | Encourage improvements to the current local bus services to provide improved access to retail and business premises   |
| 63           | Have traffic monitoring performed in Kings Copse Avenue by Hampshire Highways and a road safety inspection performed by Hampshire Police to explore possible mechanisms to calm traffic, reduce and enforce speed limits  |
| 64           | Work with Hampshire Constabulary to achieve effective enforcement of speed limits and vehicle weight restrictions   |
| 65           | With the support of Hampshire Highways have more speed and weight limit signage   |
| 66           | Work with Hampshire Highways to explore ways to allow safer access to the Botley Mills site, so that these are in place at or shortly after completion of the Bypass  |
| 67           | Work with surrounding Parishes so that any current or improved footpaths or cycleways within the Parish might link with existing or planned footpaths and cycleways in adjacent Parishes  |
